

**TENDER NOTICE**

Sealed tenders are invited from reputed / competent and sound recycler for sale of once used lube oil. The offers may be sent in their Letter Head pad addressed to the “Managing Director, Assam Gas Company Limited, Duliajan---786602, Distt : Dibrugarh (Assam)” and will be received up to 2-00 PM on **06/11/2009**.

1. The Tender should be submitted in two bids system as under :

- a. Techno- Commercial bid
- b. Price bid

2. The Techno- Commercial bid shall contain the following documents :

- (i) The authorization certificate from “ State Pollution Board” and registration certificate under “ Central Pollution Control Board”, Ministry of Environment and Forest, Govt of India under the hazardous waste management and Handling Rules 1989 and as amended..
- (ii) All necessary documents of packing, labeling, storage and transportation of hazardous materials are to be submitted from respective “ State Pollution Board” / Competent Authority.
- (iii) The interstate permission certificate from each “ State Pollution Board” are to be submitted in case of hazardous chemicals are to be transported through various states.
- (iv) **EMD of Rs 5,000.00 (Rupees Five Thousands)** only in shape of Demand Draft from any Nationalized Bank in favour of Assam Gas Company Limited payable at Duliajan.

3. The Price bid should contain the following documents :

- (i) The quoted Price in the prescribed format in Annexure—I.
- (ii) The Price to be quoted excluding VAT.
- (iii) Offer validity of 180 days from the date of closing tender.

4. The both envelopes of Techno- Commercial bid and Price bid should separately marked with “Techno- Commercial bid ‘ and “Price bid” along with Tender Number and date for easy identification. The both the sealed envelopes should be put together in a single envelope along with Tender Number and due date of submission.

5. Assam Gas Company Limited, Duliajan will not be responsible for any late submission of tender or non receipt of tender.

6. The 'Price bid' of only successful bidders will be opened and bid of unsuccessful ones will be returned as is where is basis.

- (ii) The lube oil should be lifted within the specified date and time as per the laid down conditions of the Purchase Order.
