Terms & Conditions for Limited Tender:

1. The bidder must be original manufacturer or authorized dealer/ reseller of above items. The bidder has to submit authorization certificate from manufacturer or its area representative with up to date validity.
2. **Bid evaluation criteria:** Eligible bidder shall be evaluated based on item wise maximum discount offered on MRP. Hence bidders are requested to quote their rates with maximum discount. The manufacturers' price list must be enclosed along with bid offer to justify MRP.
3. **Order quantity:** The quantity shown in Annexure-I are tentative required quantity for the whole year which may either increase or decrease. AGCL shall place order based on immediate requirement to the eligible bidder.
4. **EMD:** No EMD is required to deposit against the tender. However, eligible vendor may have to deposit EMD before placement of P.O. if the order value exceeds Rs. 50,000.00. EMD shall be refunded after successful completion of all the terms and conditions of the P.O. EMD may be forfeited if the vendor fails to execute the P.O. & action as per Co's norms will taken against such vendor.
5. **Bid Validity:** The bid validity period is 365 (Three hundred Sixty Five) days from the date of opening of the tender. Any bidder whose bid validity is less than 365 (Three hundred Sixty Five) days shall not be considered.
6. **Delivery:** The delivery of the all ordered goods is at AGC, Duliajan. Bid offer with FOR other then Duliajan will not be accepted. The delivery period shall be 30 (Thirty) days from the date of receipt of the Purchase Order by Email.
7. **GUARANTEE/WARRANTY:** Guaranty/Warranty shall stand as per manufacturer certificate. Warranty must be valid for minimum 1(one) year from the date of supply. If any defect found during inspection & use, the same should be replaced by the vendor at free of all charges.

8. **Liquidated Damage:** The completion of delivery of the ordered item as mentioned above within the schedule date of completion of delivery shall be deemed to be the essence of the contract. In case of delay in delivery of the materials within the stipulated period, unless such delay is attributable to owner (AGCL) or due to Force Majeure, there will be reduction in contract value @ 0.5% (Point Five Percent) per week for undelivered quantities of materials for each week of delay or part thereof subject to maximum of 5% of the total contract value, as liquidated damage. The Liquidated Damage charge shall be recovered from the supplier's bill / invoice.
9. **Payment :** The company shall try to release 100% (Hundred Percent) payment to the supplier after complete supply and acceptance of materials. The vendor shall submit original invoice in triplicate along with all necessary supporting documents as per P.O. and the NIT. Payment will be done through RTGS only. So, the bidders are requested to provide the following Bank details :- a) Bank Name b) Branch Name c) Account Number d) IFSC Code.

General Terms & Conditions :

1. The TOTAL AMOUNT shall be in figure as well as in words. No overwriting shall be allowed. In case of discrepancy, the rates quoted in words shall be considered to be correct.

Dibrugarh (Assam) on or before the bid closing date and time as mentioned above. If the bid closing date happens to be holiday/bandh call then the next working day will be considered as bid closing date. In case next working day is Saturday, the bid closing date shall be Monday.
